



USER LICENSE AGREEMENT

This is an agreement ("Agreement") between Francesco Biondi, as the composer ("Licensor"), and you, the end user ("Licensee"). By purchasing a license from Licensor, you agree to be bound by the following terms and conditions as same pertain to the license you purchase.

License Grant

Licensor grants to Licensee a non-exclusive, perpetual, worldwide license to use the musical composition(s) specified in the License Agreement for a single end product, according to the end-use or audio-visual synchronization model chosen by Licensee. The license grants the following usage rights, depending on the end-use or audio-visual synchronization model chosen by Licensee:

- **"Web License"**
For most web uses, YouTube monetized videos, social media, vlogs, online corporate videos promoting a product, service or brand, charity films, tutorials for business websites.
- **"TV & Radio License"**
For TV and radio productions up to national broadcast: commercials, shows, series, pilots.
- **"Games & Apps License"**
For commercially distributed products such as apps, video games, and audiobooks.
- **"Theatrical License"**
For theatrically released films; OTT/VOD; unlimited distribution of DVDs.

Restrictions

Licensee may not:

- A. Sell, resell, trade in, or give away the music to any other party or otherwise distribute the music "as is."
- B. Create/produce new musical works based on the music (musical compositions, songs).
- C. Use/include the music in different types of music compilations, such as music compilation CDs/DVDs or music albums where the tracks are stand-alone elements.
- D. Record the music under any Content ID fingerprinting system such as AdRev, Identify, TuneCore, etc.
- E. Redistribute the music as a part of different multimedia templates (e.g., website templates, video templates, e-card templates, slideshow templates) that are subsequently offered to multiple end-users.
- F. Use or redistribute the music as a part of telephone or mobile phone ringtones.

Cue Sheet

For TV and film productions, or licensed works associated with a cue sheet, the cue sheet must indicate that the Composer is Francesco Biondi, and that the Composer is affiliated with BMI (IPI# 00542050494). Please contact the composer for information regarding the ISWC code associated with the licensed work.

Licensor shall not be liable to Licensee for any indirect, incidental, consequential, special, or punitive damages, or for any lost profits or revenues, arising out of or in connection with this Agreement, even if Licensor has been advised of the possibility of such damages.

Miscellaneous

This Agreement constitutes the entire agreement between Licensor and Licensee regarding the use of the musical composition(s) and supersedes all prior or contemporaneous agreements or representations, whether written or oral. This Agreement may not be modified or amended except in writing signed by both Licensor and Licensee. This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction in which Licensor is located, without giving effect to any principles of conflicts of law.
